# 2. AGM business - Nomination of Office Bearers and Secretary; Group membership fees for 2020-21.

#### 5. Mechanisms to manage deer.

Foot and helicopter count 2021. To carry out the foot count irrespective of helicopter count as soon as possible after hinds. AMcM reports funding secured but there could be restrictions related to COVID to put a stop to that. EKDMG concerned about cost to their group in the light of current financial challenges. EKDMG also committed to a foot count. Action: JB to coordinate the foot count.

Stag numbers – nothing from JMT, Action: CM to chase plus info on OoS license application.

Cull targets and population model for WKDMG and the wider combined west and east KDMGs (Papers 3.1, 3,2, 3,3). Strong hind cull is needed in 2020/21. Informal group-wide check on numbers taken from end of year might help to deliver that.

Venison market – if carcass disposal is not possible then what happens? Taking an early cull may be helpful for this.

#### 6. Delivery of designated features into favourable condition

See HIA report 2020 (Paper 4). Great to see the HIA work from Barisdale;. Serco satellite mapping of Kilchoan and Camusrory showing bracken cover. Action: all areas with HIA in place to resume in 2021.

Asked NatScot whether there is any financial support to deliver the culls required. AMcM – none that he knows of yet.
